## Creating a More Perfect Union

In celebration of the  
250<sup>th</sup> Anniversary of the  
*US Declaration of  
Independence*, The National

Endowment for the Humanities is awarding  
small grants of \$50,000 to each of its 50 State  
Humanities Councils including, of course, New  
Mexico. We're proud that NMHC reached out  
specifically to the LWVNM through its local  
leagues asking them to be the main planners  
and advisors for events during this yearlong  
celebration. This yearlong initiative by NEH  
takes its title from President Biden's Inaugural  
Address:

*“The American story depends not on any  
one of us, not on some of us, but on all of  
us. On ‘We the People’ who seek a more  
perfect Union.”*

Our New Mexico initiative has been  
developed through a collaboration among our  
local leagues in Central New Mexico, Southern  
New Mexico and Santa Fe County, and the  
New Mexico Humanities Council. Bethany  
Tabor of NMHC serves as the overall Project  
Manager. NMHC and LWV have been meeting

together for about two months. NMHC submitted the proposal two weeks ago, and we should have confirmation sometime in August.

The project's main goals as stated in the proposal are:

- A group of engaged participants for future implementation activities
- The establishment of a trained cadre of conversation facilitators
- Increased appreciation for civic engagement
- Documentation of conversations with appropriate permissions to share
- Guidelines for critical assessment of information/media

A key feature of the project is Community Conversations, with an emphasis on active listening and respectful civil dialogue. At the heart of civil conversation is storytelling and illuminating every person's unique story. Narrative eliminates "winners and losers". Listening attentively to everyone's stories leads to equity and civility. We'll open our outreach relying on narrative to set the tone and to emphasize the vital importance of active, respectful listening.

Events will take place across the state. Each local league's initiative will reflect its geographic location and

character. LWVSFC will reach beyond city and county urban areas, including rural populations and listening to and learning from our Indigenous peoples. Facilitation training in various modes and using various means of teaching is crucial. We've already begun planning and outreach to individuals and local communities.

This glimpse into "Creating a More Perfect Union" is an outreach to you, the members of LWVSFC. While the Civil Discourse Project has already been active, we are not enough. Consider this an open call to join this effort to promote the conversations and events that expand our understanding of our fellow New Mexicans.

## “Experiencing High School Through a Student’s Eyes”

The first in a series of Community Discussions demonstrating Harvard Professor David Moss’s case study method for teaching civics to high school students was held on June 18 at the Academy of Technology and the Classics. Robert Sobel, a history teacher at The MASTERS Program and the first of four high school teachers who have attended the Moss workshop, facilitated the discussion.

The 16 attendees were assigned Moss’s case study entitled: *Democracy and Women’s Rights in America: The Fight over the ERA* as well as a series of questions for discussion. At the conclusion of the discussion, the attendees were asked to critique the effectiveness of the method. The results of the critiques were very positive. One suggestion was to provide more background to attendees on the case study curriculum and how it is introduced to high school students.

The ERA case was written in rich detail by Moss and enhances the materials and presentation method that Robert uses when teaching. The point of the teaching method is to demonstrate a better understanding of the deliberative and decision-making skills necessary for self-government.

Robert told the group that he has seen positive results with his students after using the case study method. The students say that the method increased their interest in

government and its legislative bodies and demonstrates the importance of choosing your elective officials carefully. Voting becomes an important activity for them and they realize much more that their vote matters.

The Moss curriculum supports the League’s interest in providing tools to history teachers for teaching civics. It is an important part of the High School Civic Project that includes registering students to vote and providing opportunities for students to participate in community events or lobbying for legislation.

### What League activities are you involved in?


I am a member of the Civil Discourse Project (CDP) and feeling like it's a good place for me.


In *Homeland Elegies* by Ayad Akhtar, the narrator, who shares his name and profession with the main character, finds himself, according to the *Observer*, “still entirely shaped by the Islam that had socially defined him since 9/11”, opposed to “a culture that didn’t understand us, that didn’t want us”. In writing about his experience, he tells the story of his upbringing as the son of Muslim immigrants from Pakistan, through family, politics, art, money, sex, religion, and prejudice.

Akhtar weaves fact and fiction, memoir and history into a novel making it impossible for the reader to separate the two. His story is told in separate experiences that all have a beginning and an end, an approach that gives the reader insight into his world. Akhtar provides insight in how we evolved from a multicultural country to a nation at odds with itself.

A Pulitzer Prize-winning playwright colleague states: “[The novel is a] trenchant tale that...reveals the multidimensional and paradoxical journey of...belonging in our fractured American culture.

Illuminating eloquent, and painfully honest, it should be read by all”.

I recommend this book, which was awarded the Kirkus Best Book of 2021, for the insight it provides about our American culture and how to understand how we arrived at a divided nation unable to work together. It also asks what role the reader played in creating this unworkable situation.



*All the Devils are Here* is the 16th novel of the Chief Inspector Armand Gamache of the Surete du Quebec Series by Louise

Penny. It is a # 1 New York Times best seller and the winner of the Agatha Award for best contemporary novels.

The Canadian author’s usual backdrop for her series is Three Pines, Quebec, a small village on the Canadian US border, but in *All the Devils* Gamache and his wife Reine-Marie travel to Paris to visit their son and daughter. As the story unfolds, Gamache’s godfather, Stephen Horowitz, is hit by a delivery van and critically injured. Gamache knows that it is not an accident. As Gamache

starts his investigation, he and his family are caught up in a web of lies and deceit. In his quest for the truth, he will have to figure out who he can trust, questioning the sincerity of those closest to him. *All the Devils* continues with the theme underlying all of Penny's novels—Honor Thy Family—the one you were born with, the one you've acquired during your lifetime and the Family of Man.

I fell in love with Penny's novels a few years ago. Penny creates plots that include murders by unconventional means, a large cast of "characters" and suspects, red herrings and dramatic endings exposing the unlikely murderer. I hope you will find it worthwhile to spend some of your summer in Penny's world.


