## New Initiatives

- **Outreach Project:** We have added a position on the Leadership Team dedicated to community outreach and collaboration with other like-minded organizations.
- **Diversity Fund:** We now offer scholarships to potential members who will contribute to the diversity of the membership and help us expand our services to a broader constituency.
- **Social Media Project:** We have invested in an update of our communications methods and established a social media presence for the first time.
- **High School Civic Project:** We train high school students to provide voter registration services and coordinate civic projects in their own schools.
- **Civil Discourse Project:** We work to promote authentic, mutually respectful, and constructive communication for the purpose of improving public policy processes and decisions.
- **Good Governance Project:** We work with members of the city's governing body to review proposals to revise its structures and processes and provide comments, questions and recommendations for improvement.



## Why Fundraising is Critical to Our Survival

The pie charts below give you a snapshot of our budget. As you can see, our projected revenues add up to \$27,945 and our projected expenses add up to \$27,276. We expect to end the year with an excess of revenue over expenses. Having said that, it's important to point out that our balanced budget assumes we will raise \$13,000 this year through member donations and fundraising. That is the highest fundraising goal we've ever set for ourselves. But we believe we can do it...and we will.



### Things You Should Know About LWVSFC's Revenue:

- We only keep \$15 of your \$60 membership fee (\$32 goes to National and \$13 goes to State).
- Membership Dues and Event Fees pay for approximately 50% of our expenses.
- We rely on Member Donations and Fundraising to pay the other 50% of our expenses.

### Things You Should Know About LWVSFC's Expenses:

- 89% of our budget goes to voter education, action and advocacy: LWVSFC's mission.
- Only 7% of LWVSFC's budget goes to administrative expenses.
- We are an all-volunteer organization, so 0% goes to salaries and benefits.

## **Introducing LWVSFC's New Planned Giving Program**

This year we are launching a Planned Giving initiative to honor the work of our members—past and present—and to ensure that there will be a future for the LWVSFC. Now, in addition to asking for cash donations, we are also offering two simple planned giving options—one you can do to qualify for tax benefits while you are alive and another designed to leave a legacy after your death.

Feel free to contact us if you have questions about the options we've included in this article, or if you want our help in pursuing one or both of them.

### **Option One: Qualified Charitable Distribution (IRA charitable rollover)**

If you have invested in an IRA, annual withdrawals are required after age 72. These are referred to as required minimum distributions (RMDs). There is a penalty for not taking your RMD and, when you take it, it is taxed as income. However, you can arrange for your RMD to be transferred directly to a qualified charity and thus avoid paying income tax on it. If you don't need your RMD for living expenses, this strategy is a "win/win" for the donor and recipient. Setting up a Qualified Charitable Deduction from your IRA is easily accomplished by contacting your IRA provider. You will be asked for the following information about the LWVSFC:

### **Option Two: Make a Gift to the LWVSFC in Your Will**

If you are interested in securing the LWVSFC's future with a gift from your estate, a bequest in your will leaves a legacy behind after your death. Language can be included in your will gifting a specific dollar amount, a percentage of your estate or an amount from the balance or residue of your estate. You can also designate it for a specific fund or program if there is one you want your donation to support. Most recently, we received a major donation from long-time member Becky Frenkel's estate. We wish Becky was still with us in person, but this gift ensures that she will remain with us in spirit long into the future. Though this option requires some paperwork, we will be happy to provide sample bequest language and meet with you to work out the details.

## Recommended Reading

### *The Growing Threat of Gender Violence*

This September Dr. Rebecca Álvarez, an active member of the LWVSFC, published her first book, *Vigilante Gender Violence: Social Class, the Gender Bargain, and Mob Attacks on Women.*\*

The issue of gender violence is urgent. Álvarez, assistant professor of Sociology, Anthropology, and Criminal Justice at New Mexico Highlands University, opens Part I with a narrative of the very public rape, beating, and murder of Jyoti Singh on a city bus in New Delhi, India, in December 2012. Álvarez acknowledges that “All human societies known to history have carried a greater or lesser undercurrent of violence against the bodies of women.” However, she then asserts that Singh’s murder is one example of a different kind of violence against women; a public violence, directed by strangers against a random victim, and shocking in its ferocity.

This book is not sensationalism. It is a sober, clear-minded analysis of why this type of attack is increasing globally, not just in the non-Western or

so-called “third world,” but also in wealthy, educated nations throughout the globe.

Álvarez presents her thesis in Chapter 2. Social change leads to gender violence in a lethal blend: the weakening of the “gender bargain” that allows men of all classes to feel superior to women, the increasing social stratification across the world, and the sociocultural evolution of societies from hunter gatherer, to horticultural, agrarian, industrial, and finally, post-industrial.

In Part II, Álvarez leads the reader through four pertinent, specific case studies in Papua New Guinea, Afghanistan, South Africa, and the US. Part III poses the obvious question, “Where do we go from here?” The final two chapters address the challenge of predicting vigilante gender violence and then preventing this global phenomenon. Throughout, she makes her point that vigilante gender violence, or gender “lynching,” is not about random isolated incidents. The causes and pattern are clear. Equally clear to the reader at the book’s conclusion are potential solutions.

## New Opera Honors Civil Rights Pioneer Fannie Lou Hamer

“Black lives matter,” they chant, marching single file up the gangway of the *Mary A. Whalen*, a historic oil tanker anchored in Red Hook, Brooklyn. Masked and garbed in funereal black, the chanting chorus circles on the deck. “They are going to kill us anyway,” two protagonists argue in frustration over the futility of voting.

This is the opening scene of a bold new production by the **Santa Fe Opera** in conjunction with Opera for All Voices, a consortium of North American opera companies, on the life of **Fannie Lou Hamer**, voting rights advocate and civil rights pioneer. The scene was presented in a workshop with the CCA on October 23 entitled ***Is This America?*** A combination of gospel, operatic song, and verse set the stage for conversation on Hamer’s heroism in speaking truth to power, and her eventual victory in the **Voting Rights Act of 1965**. In her own words, sung searingly by Nicole Joy Mitchell,

*“Is this America, the land of the free and the home of the brave, where we have to sleep with our telephones off the hook because our lives be threatened daily, because we want to live as decent human beings, in America?”*

A group of generous supporters of **Santa Fe Opera’s Community Education** program underwrote this live recording and streaming so its message could be appreciated before Election Day, 2020. A full presentation of the opera on Hamer’s life, ***This Little Light of Mine***, will be workshopped in 2021. ## Committee and Project Reports November 2020

### **Action & Advocacy**

The 2020-21 A&A priority matrix and our communications to public officials are now posted on our updated A&A page on the website. Documents include: Letter to the City (July) regarding concerns about the accuracy of information for online meetings; Letter to the City (October) about the transparency of the Health and Safety Task Force; Letter in the *New Mexican* (October 20) on Task Force transparency. The Midtown Campus Project development team is now performing a SWOT (strengths, weaknesses, opportunities, threats) analysis to help guide the planning process.

### **Civil Discourse Project**

The CDP has received Board feedback and approval for a set of principles and guidelines for the new Discussion Forum, slated to launch in November, which will be located on our website. The Forum will be open to all members (details on page 10).

### **Membership**

The LWVSFC now has 181 members, including four Life Members and eight members sponsored by the Diversity Fund. Our membership is 66% up to date with 34% still needing to renew. We will soon be offering monthly Zoom Happy Hours for all members, and new member “teas” to orient new members to the opportunities for participation and to meet the leadership team.

### **Outreach Project**

From August 5 to September 22, our volunteers, organized by the Santa Fe

Complete Count Committee, participated in a phone banking campaign in Santa Fe County: 16,778 phone numbers were called and 1,390 individuals were talked to about the 2020 census.

### **Program**

In October, the LWVSFC was honored to hear a presentation from Early Childhood Education and Childcare Services outlining the department’s recent progress. The report and detailed statistics—critical for advocacy during the next legislative session—will be posted on the website as they become available.

### **Voter Information**

We passed out over 750 copies of our Voter Guide at early voting sites all around the county. Additionally, the Guide appeared in the *Santa Fe New Mexican* on October 4. Sponsored by the LWV Education Fund, VOTE411.org was a big success. We are waiting for usage numbers from National.

### **Voter Registration**

Pre-election activities included distributing 7,065 get-out-the-vote flyers to food pantry clients; providing face-to-face voter registration and information at six locations to 439 individuals; and answering 130 Help Line calls. A special thanks to the volunteers who provided voter registration and information services for residents of Santa Fe: **Irene Epp, Susan Pfeifer, Betsy Siwula-Brandt, Mary Schruben, Iswhari Sollahub, Sharon Porter, Lucy Foma** and two bilingual volunteers, **Win Speicher** and **Charlotte Rivera**.


